In addition to these published articles and reports, our website features **20 FRPN-funded evaluation studies** of fatherhood programs and research into issues that impact fathers and child well-being. Several FRPN grantees completed exploratory and descriptive research studies that provide insight into previously unstudied or understudied areas. Other studies included projects led by researcher/practitioner teams that involved the collection of data from program participants and/or staff at pre- and post-program time points to assess changes in father-child involvement and coparenting.



## FRPN Co-Directors Publish New Study on Coparenting Intervention in Fatherhood Programs

Which mothers will agree to participate in a mother-only coparenting class conducted in a fatherhood program? **This article** presents multivariate analyses that use data from 277 fathers attending fatherhood programs in five urban and two/rural small town agency sites. It finds that the biggest predictors of mother participation are: recent legal challenges; father-mother relationship quality; father-mother alliance; and rural/small town residence. Fatherhood programs should try to address the issues that appear to deter mothers from participating in coparenting interventions: high levels of couple conflict, recent father incarceration and recent father trouble with the law.
