This comparison of child support payments and arrears balances in Wisconsin, before and after the state reduced the interest rate it charges on unpaid child support from 12 to 6 percent per year, found that the reduction slowed the growth of child support arrears and improved payments made by noncustodial parents. According to FRPN's *Policies and Programs Affecting Fathers: A State-by-State Report* ([Chapter 2](#), Table 2), 24 states and the District of Columbia do not charge or collect any interest on unpaid child support, while 26 states impose interest charges that range from 2 percent to 12 percent per year or are based on market factors.
