New Article on FRPN Grantee Research Published

Dr. Julia Kobulsky and Rachel Wildfeuer (Temple University) have authored a new article published in *Child Maltreatment*, along with Susan Yoon (Ohio State University) and Jamie Cage (Virginia Commonwealth University). This study built on previous research funded by a grant from the FRPN. The study shows that investigations by Child Protective Services (CPS) are more likely to result in criminal investigation and criminal charge in cases that involve father-alone perpetration as compared to mother-alone-perpetration. The greatest risk for criminal charges being filed was when a Black father co-perpetrated maltreatment with the mother. Findings imply the need for prevention and intervention services that engage fathers and anti-bias training for professionals involved in maltreatment investigations.

Deadline Extended for SIRF Project Nominations

MDRC will select up to 10 responsible fatherhood programs to participate in The Strengthening the Implementation of Responsible Fatherhood Programs (SIRF) project, which is studying ways to help programs overcome common implementation challenges and test possible, real-world solutions. Practitioners in selected programs will collaborate with researchers to identify challenges, devise solutions, implement them, examine their effect on participants, adjust the solution based on research feedback, and repeat the process again or multiple times. Funded by the Administration for Children and Families' Office of Family Assistance, selected programs will receive payment for the costs associated with their participation in the project. The deadline for submitting program nominations has been extended to this **Friday - October 16**.
